Highlands United Church Stewardship 2020 Pledge Form

Why Pledge?

When you enter into a financial pledge, it allows Highlands to make plans and commitments for our programs and staff for the coming year. If circumstances change during the year and you need to adjust your pledge, please let our office know.

Ways of making your pledge contributions

- Monthly PAR: (Pre-Authorized Remittance) Your donation is transferred automatically from your bank account on the 20th of each month. (Highlands pays no commission on your givings.) If you are a new PAR giver, there is a request form to be completed—see the PAR brochure which is included in the pouch, or visit the Church Office.
- **Post-dated Cheques:** Please send in a set of post-dated cheques to the Church Office, or place them in the envelope with your pledge. Your cheques can be for each month, each quarter, or at whatever intervals you choose.
- Weekly Envelopes: You will receive a set of dated, numbered envelopes, to hold your weekly donation when you put it in the offering plate.
- VISA/Mastercard: (Monthly) Your donation is charged automatically to your credit card account on the 20th of each month (Highlands pays 2.5% commission).
- **Other:** Some people prefer to hand in cheques periodically during the year, or donate through the United Way.

Receipts

All your pledge donations are tax-receiptable. You will receive a periodic statement of your donations, and a tax receipt at year end.

Under current Canadian tax laws, you receive a tax credit of up to 43% of the charitable donations you make in a year (20.06% of the first \$200, 43.7% of the remainder). As an example, giving \$10 each week will mean that you are eligible to receive a tax credit of \$180.
